Biography

Deirdre McDermott is an architect, planner, urban designer, in private practice. She is an active member of both the Irish National Committee of ICOMOS and of the Advisory Committee.

Elected as VP in Fukuoka in 2015, she has been working with the six ACOs to secure the effective operation of ADCOM in all its aspects. She is responsible in particular for the inauguration of an annual meeting of the National Committee (NC) presidents and seeks to use this NatCom forum to share the experiences and successes of the NCs, to encourage and reanimate struggling committees and to address issues of concern to this constituency. She has worked towards the involvement and integration of the EPs and sustainable access to meetings through streaming and digital technologies.

Deirdre is a registered architect, a qualified planner and urban designer and principal in Deirdre McDermott and Associates. Currently based in Co Galway, Ireland, she has worked principally in Ireland, the UK, Africa and France. She has worked extensively in area based regeneration, urban design and conservation in Ireland, France and the UK and recent work includes a series of collaborative projects in small towns and villages and restoration and conversion projects on traditional buildings in France, designed to reintroduce sympathetic economic activity in small villages on the mediterranean fringe, as well as a range of conservation projects in Ireland. She has worked with a number of major private and public clients on mixed use developments where the focus has been on integrating new development into existing towns and cities. The practice completed the National Inventory of Architectural Heritage for the North Georgian City of Dublin.

She completed a Diploma in Architecture and a Masters in Urban Design with a double distinction in Oxford, undertook the RIAI Conservation Accreditation Grade III and in 2011 completed the MUBC in UCD.

Deirdre served for six years as a member of the Historic Buildings Council, an advisory body to the Environmental Heritage Service in Northern Ireland, reviewing their First and Second (Listed Buildings) Survey.

She was a co-opted member to an advisory body established by the Irish government to develop policy on architecture and on the architectural heritage in State Care (Action on Architecture 2002 - 2005)' which preceded and recommended the establishment of a conservation accreditation system within the Royal Institute of Architects of Ireland. She was President of the Irish national Committee of ICOMOS for six years and is currently:
