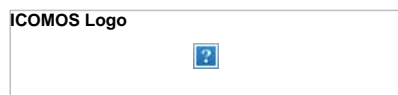

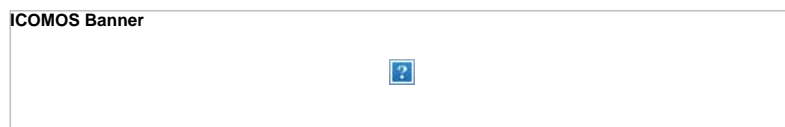

## 2018 Annual General Assembly – Buenos Aires, Argentina Last days to register and Preliminary agenda now available

As announced in previous e-news, this year, the ICOMOS Annual General Assembly and Advisory Committee will take place in Buenos Aires, Argentina, from 4-8 December 2018, on the generous invitation of ICOMOS Argentina. **We invite you to proceed quickly to your registration and the organization of your trip.**

### Registration open until 19 October (this Friday)

Consult the site <http://adcom2018.icomos.org.ar/en/> for all practical information – registration, hotels etc. (versions of the site in **French** and **Spanish** are also available). Registration is open until 19 October 2018. Before registering - please consult in particular the page "Information for Delegates" and after registering - please carefully read the information provided by the Conference Organiser and keep an eye on the updates on the website.

You will find the **programme** on the website in **French, English** and **Spanish**.

**The current situation of the Argentine peso has led to a sharp rise in tourist bookings in Buenos Aires for the coming months, therefore you are strongly advised to book your air tickets and accommodation as soon as possible.** You will find suggestions for accommodation on the website of the General Assembly. Also, **if you need a visa for Argentina, please get in touch with ICOMOS Argentina as soon as possible** - the procedures to obtain a letter of invitation are quite long because you have to make them certify by a notary public in Argentina - for more information: <http://adcom2018.icomos.org.ar/en/visa/>.

### Preliminary agenda available

You can now download it in **English, French** and **Spanish**.

The agenda of the Annual General Assembly, on 6 December (9:00 - 11:00 am) will focus on receiving the reports of the ICOMOS President and Treasurer on the management by the Board and the health and financial situation of the association; approving the annual report and accounts and discharging the Board, as well as voting next year's budget. All other matters such as adoption of doctrinal texts, elections of the Board and officers, conferring of Honorary membership, voting the ICOMOS General Programme and budgetary guidelines for the next triennium, as well as proposing resolutions for adoption by ICOMOS will be dealt with by the next triennial General Assembly (2020, Sydney, Australia).

All members shall have the right to attend the General Assembly and may be designated to be a voting member at the General Assembly within the conditions set out in Articles 9-a and 13-d-4 of the Statutes. Please note that additional Committee observers and voting members (beyond the Committee Presidents or their designated representative) are asked to contribute a registration fee.

### Working documents

The other working documents (e.g. financial report) will be posted on the General Assembly's website ([here](#)) and circulated via the ICOMOS e-News at least 4 weeks before the start of the meeting.

### Remote participation at the meetings

The Annual General Assembly and Advisory Committee meetings will be made available as video recordings to ICOMOS members – via the ICOMOS website. More information will be posted closer to the meeting date.

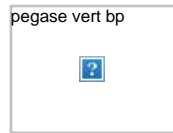
