

To whom it may concern,

When I started the recovery of an 6,500 year old, but still living, fragile and evolutive, terraced saltworks in 1999, no information about a similar site or intervention existed. Facing the unknown once again, I led the multidisciplinary team that carried out the Master Plan, the research and the intervention works. Fundraising and negotiating with every stakeholder led to the creation of a Foundation that I managed. Sustainability regarding to management and preservation and community engagement was vital to be selected Candidate to World Heritage in 2012 and be awarded by Europa Nostra in 2015. Adapted to the 21st century, while keeping to authenticity, Añana Salt Valley is today an example of success.

During my experience in such a unique site as Añana, I have felt the need to search for new boundaries in heritage conservation theory to justify the authenticity and integrity of the interventions and the site itself. As a result a book was published in 2014 together with Alazne Ochandiano: "*Añana Salt Valley. Architectural preservation manual*", while was invited to participate in the 2014 Nara+20 meeting. Furthermore, my more than two decades devoted to heritage conservation projects, has given me a strong technical background, that combined with teaching *wood and heritage conservation* for 25 years at the Graduate level complete my profile.


